ACKNOWLEDGEMENT, ASSUMPTION OF RISK, RELEASE OF LIABILITY AND INDEMNIFICATION AGREEMENT

I,, acknowledge receiving permission from the Nashville gui	n
Club ("NGC") for the use of club facilities and premises located in Nashville, Tennessee and the	
owners of the premises and the State of Tennessee (collectively "Landowners"), for the purpose of	
sporting clay shooting, instructional clinics, trap shooting, skeet shooting, five stand shooting, sport	
and other target shotgun shooting and other recreational activities.	

I understand and accept that receiving permission from NGC for the use of the premises does not contain any assurance from any released or indemnified party that NGC is safe for the permitted purposes either upon the date of entry or at any time in the future. I further understand and accept that neither NGC, nor the Landowners assume any responsibility or liability for any injury to or death of myself caused by the condition of the NGC, the negligence of the NGC and the person or persons to whom a similar permission has been granted. I further acknowledge and accept that the possibility of injury or death exists in dangerous pursuits such as the use and shooting of shotgun firearms only and the other recreational activities herein described. I further understand and accept that I shall at all times be responsible for my own safety and the safety of my children while at NGC. I further acknowledge and accept all of these dangers and hereby release NGC and the Landowners and all employees, or board of directors from any liability for negligence for failure to make NGC safe or failure to warn of an unsafe condition or from any other liability resulting from any injury or death from the use of any shotgun firearm or supervision of any use of any shotgun firearm by NGC, the Landowners, their agents, guests, employees and any other persons. I further acknowledge and agree to completely and absolutely indemnify and hold harmless NGC and the Landowners from any loss or damage, financial or otherwise, including all costs and attorneys fees for any claim brought against NGC or the Landowners by any other member of guest arising out of any injury or death resulting from any act or thing done by me in connection with the use of a firearm or while using the premises in connection with any other recreational activity.

I understand and agree that NGC Rules prohibit the operation of any motor vehicle by any member or guest beyond the regular road and parking area located on the premises. I acknowledge and agree that there are several areas of hazardous terrain on the premises. In the event I undertake to operate a motor vehicle off the regular road on any hazardous terrain, I agree to assume all risk in connection with the operation of said vehicle upon said terrain and I further agree to indemnify and hold harmless NGC and the Landowners from any and all loss of damage, financial and otherwise, including all costs and attorneys fees from any claim brought by me or any member or guest of NGC or the Landowners arising out of any injury or death resulting from any act or thing done by me in connection with the use or operation of said motor vehicle.

I understand and accept that the consumption of alcohol, marijuana and/or any other drugs, legal or otherwise, may impair my ability to participate in any event or operation of a shotgun firearm at NGC or the Landowners. I agree that if I do consume alcoholic beverages, marijuana and/or any other drugs, legal or otherwise, I fully assume all risks associated therein and agree to indemnify and hold harmless NGC, the Landowners, their agents, guests, employees, board of directors or any other persons.

With the foregoing and all acknowledgements, assumptions, releases and indemnifications set forth above, should I elect to be accompanied by a minor child(ren) whose name(s) appear below (minor child) I also execute this acknowledgement, assumption, release of liability and indemnification agreement for and on behalf of him or her as the parent of said child(ren) to the fullest extent possible under law. Moreover, should a cause of action occur to the minor child(ren) for any reason whatsovever against NGC or the Landowners, by reason of said child(ren)'s use of Landowners' property, the undersigned shall completely and absolutely indemnify and hold harmless Landowners for any loss or damage, financial or otherwise, including all costs and attorneys fees related to any cause of action which may be asserted against NGC and/or the Landowners by me on behalf of said minor child(ren) or by any other parent or legal guardian on behalf of said minor child(ren) or by undersigned minor child(ren) after he or she attains the age of minority.
